The First PhD Residency at GUSS



The first PhD program residency was held at the Georgian University of Social Sciences on Saturday, January 13th. Residency I was the first experience for all the PhD candidates. This day was memorable for them in terms of the discoveries they had made together and the implications of the residency for the program.

This was the first of the three residencies that the PhD program involves. A residency reflects the interests of the candidates as it provides space for the consideration of these interests.

The purpose of the doctoral program is to prepare scholars for the elaboration and dissemination of knowledge. The development of knowledge embraces the generation of new ideas and applications; and the dissemination of knowledge implies the presentation of the ideas and applications through publications, teaching and scholarly presentations.

The Georgian University of Social Sciences is a community of learners. At the Bachelor's and Master's degree levels, the students and the professors meet on a regular basis; these meetings take place not only in classrooms, but also in the hallways, the Library, the Bookstore and the Canteen. At the Doctoral level, where emphasis is placed on individual research, the PhD candidates only have brief meetings every week. Residencies provide an opportunity to meet for a longer time and share the progress and concerns of the candidates.
